MANAGEMENT DISCUSSION OF FUND PERFORMANCE

Investment Objective and Strategies

The objective of the Pender Alternative Arbitrage Fund (the "Fund") is to generate consistent, positive returns, with low volatility and low correlation to equity markets by investing primarily in North American securities. The Fund may also invest in foreign and other securities.

PenderFund Capital Management Ltd. ("Pender") is the Manager and Portfolio Advisor of the Fund.

Risks

The risks of investing in the Fund are outlined in the Simplified Prospectus dated June 28, 2024. There were no significant changes to the Fund's objectives and strategies that affected its overall level of risk during the year.

The nature of the Fund's investing activities exposes it to various risks, including but not limited to inflation and the impact of central bank measures on the economy, the state of M&A markets, geopolitical and other global events, factors that are beyond the Fund's control.

Future developments in these challenging areas could impact the Fund's results and financial condition and the full extent of that impact remains unknown. Developing reliable estimates and applying judgment continue to be substantially complex. Actual results may differ from those estimates and assumptions.

Results of Operations

The net assets of the Fund were \$14,733,235 as at December 31, 2024 versus \$22,046,529 as at December 31, 2023. Of this \$7,313,294 decrease, \$898,275 is attributable to positive investment performance and \$8,211,569 is attributable to net unitholder redemptions of Fund units.

For the year ended December 31, 2024, Class A units of the Fund generated a total return of 2.7%. Returns for other classes of the Fund will be similar to Class A with any difference in performance being primarily due to the different management fees that are applicable to different classes. Returns for Class F (USD) and Class I (USD) will differ from Class A primarily due to foreign currency as these classes are denominated in US dollars whereas all remaining classes of the Fund are denominated in Canadian dollars. Please see the "Past Performance" section for the performance of the Fund's other classes.

The Fund's benchmark, HFRI ED: Merger Arbitrage Index (USD), returned 5.9% during the year. In accordance with National Instrument 81-106, we have included a comparison to this benchmark to help you understand the Fund's performance relative to the general performance of the market, but we caution that the Fund's mandate may be significantly different from the index. Further, the Fund's returns are reported net of all management fees and expenses for all classes, unlike the returns of the Fund's benchmark, which are based on the performance of an index that does not pay fees or incur expenses.

The following comments and the comments under "Recent Developments" reflect the views of the portfolio management team and are based on information as at the end of the year. Please read the caution regarding forward-looking statements located on the last page of this document.

The Fund's underperformance as compared to its benchmark was mainly due to an overweight allocation to both the Energy and Industrials sectors. We do not actively manage sector weightings in the Fund, rather, our sector weightings are determined by individual stock selection through a bottom-up fundamental investment process.

Key positive contributors to the Fund's performance during the year were positions in Everbridge Inc., GAN Limited, and CSI Compressco LP. Conversely, positions in Immunogen Inc., Osino Resources Corp. and Amryt Pharma plc were key detractors.

To achieve the Fund's objective of generating consistent, positive returns with low volatility and low correlation to equity markets, the Fund employs arbitrage strategies, which are specialized investment techniques designed with the goal of profiting from the successful completion of mergers, take-overs, tender offers, leveraged buyouts, spin-offs, liquidations and other corporate reorganizations. We may also use a variety of additional investment strategies permitted within an alternative mutual fund, including but not limited to investing in special purpose acquisition companies ("SPACs"), convertible securities, and preferred shares.

Portfolio transactions during the year were made based on our investment process that aims to identify attractive arbitrage opportunities, particularly in merger deals. In general, we added positions to the portfolio that we felt offered an attractive spread relative to the probability that a merger deal will close. The strategy seeks to exploit this return opportunity and deliver a relatively low volatility return to unitholders. We are constantly looking for new investment ideas and we may liquidate our positions for various reasons, such as when share prices have reached our assessment of fair value, when an acquisition has occurred, or where we have changed our investment thesis.

As at the end of the year, the Fund was 95.7% invested in long positions, -7.5% invested in short positions. The geographic positioning of the Fund remains predominantly tilted towards the US with 65.1% of net exposure in this jurisdiction. The Fund remains broadly diversified across various industries and skewed to smaller companies. As at December 31, 2024, the Fund had a net exposure of 80.4% invested primarily in small, mid and micro-cap businesses. We feel this smaller market cap size is less exposed to the regulatory risk faced by larger merger deals and leverages the broader equity investment process at the Manager with its extensive research relating to smaller companies.

The overall sector exposure of the Fund is determined by stock selection decisions and may shift from time to time. As at December 31, 2024, we were weighted toward long position holdings in Financial Services, Information Technology and Industrial sectors, because those are the sectors where we believe we are finding the best investment opportunities currently. These top three sectors accounted for 51.1% of the Fund at the end of the year.

Recent Developments

Global M&A activity totaled nearly \$3.4 trillion in 2024 rising 8% from last year's decade-low levels. Notably the average deal size increased with a lower deal count in 2024. The resurgence in large transactions should drive momentum into 2025 with an increase in activity post the US election. The deal making environment was already improving going into the election with declining interest rates and strong equity markets providing dealmakers with the confidence and capital to pursue deals.

With the Trump administration election sweep and proposed pro-business agenda, we believe M&A is expected to surge. A regulatory reset with Trump appointees set to take over the Federal Trade Commission and Department of Justice, indications that corporate taxes could be cut, and the potential for more pro-growth policies should create a favorable environment for M&A activity. With major market themes including artificial intelligence, electrification and reshoring supply chains as well as a focus for companies seeking to acquire capabilities and human capital, the setup for M&A in 2025 is encouraging.

While we are encouraged about the outlook for M&A in 2025, the outlook for markets is less certain with equity valuations at historical highs, however the path of short-term and terminal interest rates is uncertain. The Fed remains in a precarious position having to balance the decline in inflation while also accounting for a stronger than expected labour market and the potential impact from the Trump administration's implementation of tariffs. With the decline in interest rates through 2024, investors have had adverse opportunities to invest with most low-risk, short-duration fixed-income investments offering a yield of less than 4%.

Alternative investment strategies like merger arbitrage offer a low-risk, noncorrelated and tax-efficient investment opportunity for investors seeking to diversify their portfolios. If inflation stays high or potentially rises due to the policies of the new US administration, there is potential for a similar environment as 2022 to materialize with tighter correlation between stocks and bonds. With a favorable outlook for M&A, wide relative spreads and compelling diversification benefits, 2025 could be the year to add some arb exposure to your portfolio.

Independent Review Committee ("IRC") Appointments & Resignations

Effective March 4, 2024, John Webster stepped down from the Independent Review Committee and John DeLucchi joined the Independent Review Committee.

Related Party Transactions

The Fund pays management and administration fees to the Manager for management and portfolio advisory services (see "Management Fees"). The Fund also pays the Manager performance fees (see "Performance Fees").

As at the end of the year, parties related to the Manager collectively held 2% of the Fund's units. In addition, the Pender Income Advantage Fund, a fund also managed by the Manager, held 19% of the Fund's outstanding units.

Management Fees

The Fund pays management and administration fees calculated as a percentage of the net asset value of each respective class. The Management Expense Ratio ("MER") before applicable taxes such as GST or HST for each class does not exceed certain levels as set out in the Fund's offering documents. The fees are calculated at the close of business on each valuation day and are paid monthly. In exchange for the administration fee, the Manager pays the operating costs of the Fund.

Management fees are used by the Manager, in part, to pay sales commissions, trailer fees, marketing costs and other associated distribution costs relating to the sale of units of the Fund.

Such expenses represented approximately 18% of the management fees paid by the Fund to the Manager for the year.

Performance Fees

The Manager is also entitled to a performance fee plus applicable taxes such as GST or HST on all classes of units of the Fund. For Class O units, this fee is or will be charged directly to Unitholders, as applicable. The performance fee is equal to 15% of the amount by which the total return of the class of units exceeds the previous high-water mark for each applicable class of units for the period since the performance fee was last paid. The high-water mark is the net asset value of the applicable class of units to which it applies as at the most recent determination date on which a performance fee was payable. Performance fees will be calculated and accrued daily, and such accrued fees will be payable by the Fund at the end of each year. The Manager has reserved the right to change the period for which any performance fee may be paid by a Fund. The Manager, at its discretion, may reduce or waive performance fees.




Year-by-Year Returns



The annual compound returns table compares the Fund's performance to one or more benchmarks. Benchmarks are usually an index or a composite of more than one index. An index is generally made up of a group of securities. Since the Fund does not necessarily invest in the same securities as an index or in the same proportion, the Fund's performance is not expected to equal the performance of the index. Fund returns are reported net of all management fees and expenses for all classes, unlike the returns of the Fund's benchmark, which are based on the performance of an index that does not pay fees or incur expenses. It may be more helpful to compare the Fund's performance to that of other mutual funds with similar objectives and investment strategies.

The Fund's benchmark is the HFRI ED: Merger Arbitrage Index (USD), The HFRI ED: Merger Arbitrage Index is based on merger arbitrage strategies which employ an investment process primarily focused on opportunities in equity and equity related instruments of companies which are currently engaged in a corporate transaction. The index involves primarily announced transactions, typically with limited or no exposure to situations which pre-, post-date or situations in which no formal announcement is expected to occur. Opportunities are frequently presented in cross border, collared and international transactions which incorporate multiple geographic regulatory institutions, which typically involve minimal exposure to corporate credits
