#### MANAGEMENT DISCUSSION OF FUND PERFORMANCE

#### **Results of Operations**

The net assets of the Pender Bond Universe Fund (the "Fund") were \$65,553,793 as at June 30, 2024 versus \$61,222,878 as at December 31, 2023. Of this \$4,330,915 increase, \$1,871,356 is attributable to positive investment performance and \$2,459,559 is attributable to net unitholder purchases of Fund units.

For the six months ended June 30, 2024 (the "period"), Class A units of the Fund generated a total return of 2.6%. Returns for other classes of the Fund will be similar to Class A with any difference in performance being primarily due to the different management fees that are applicable to different classes. The return for Class F (USD) will differ from Class A primarily due to foreign currency as this class is denominated in US dollars whereas all remaining classes of the Fund are denominated in Canadian dollars. Please see the "Past Performance" section for the performance of the Fund's other classes.

The Fund's broad-based benchmark, the FTSE Canada Universe Bond Index ("FTSE"), returned -0.4% during the period. In accordance with National Instrument 81-106, we have included a comparison to this broad-based index to help you understand the Fund's performance relative to the general performance of the market, but we caution that the Fund's mandate may be significantly different from the index. Further, the Fund's returns are reported net of all management fees and expenses for all classes, unlike the returns of the Fund's benchmark, which are based on the performance of an index that does not pay fees or incur expenses.

As a result, the Fund's exposure to credit via its Pender Corporate Bond Fund holdings remains lower relative to historic weightings. The Pender Bond Universe Fund had a 22.0% weight in Pender Corporate Bond Fund units at the end of the period, resulting in a non-investment grade weight of 6.6%.

The duration of the Fund was 4.7 years as at June 30 and yield to maturity was 5.3%. Cash represented 4.0% of the portfolio at the end of the period.

The following comments and the comments under "Recent Developments" reflect the views of the portfolio management team and are based on information as at the end of the period. Please read the caution regarding forward-looking statements located on the last page of this document.

The Fund's outperformance relative to its benchmark was mainly due to its exposure to corporate credit through its investment in the Pender Corporate Bond Fund, as corporate credit has been on an upward trend. The Fund is an income fund with an investment grade focus, with an objective to preserve capital and generate returns through current income and capital appreciation.

Key positive individual contributors to the Fund's performance during the first half of the year were positions in the Pender Corporate Bond Fund, OPKO Health, Inc., and Occidental Petroleum Corporation. Conversely, positions in WarnerMedia Holdings Inc., US Treasury inflation-linked bonds, and Government of Canada inflation linked bonds were among the largest detractors.

#### **Recent Developments**

Financial markets remained buoyant through the first half of 2024, underpinned by a resilient economic backdrop and continued cooling of inflationary trends. Against this backdrop, investor confidence grew that the Federal Reserve's battle with inflation is behind us, giving visibility to a pivot in monetary policy towards cutting interest rates in the second half of 2024. Highlighting this positive investor sentiment, we saw benchmark equity indexes rally to fresh highs, while credit spreads tightened to well below 30-year averages in fixed income markets.

Credit markets are signaling a benign economic environment going forward, providing little incentive to add broad credit risk to the portfolio. Within pockets of the market, however, we are beginning to see some divergences. Although the broad credit markets remain tight, the CCC High Yield Index has widened over the period and is beginning to price in tougher credit conditions for some companies. With elevated investor sentiment and a rosy market consensus of an economic soft landing and cooling inflation, combined with elevated valuations in risk assets, we have remained selective and patient about adding risk to the portfolio.

A fundamental approach drives our research efforts. Finding opportunities that provide credit fundamentals better than their credit rating or yield may suggest, can and has in the past been a driver of returns of our Investment Grade holdings. Finding such a situation can prove fruitful through spread tightening on the back of a ratings upgrade once that value is recognized by a rating agency or the broader market. Turning over many rocks and digging deep into credit specifics is a cornerstone of our process, one that has served the fund well in the past and one that we anticipate will continue to drive relative performance.

#### Independent Review Committee ("IRC") Appointments & Resignations

Effective March 4, 2024, John Webster stepped down from the Independent Review Committee and John DeLucchi joined the Independent Review Committee.

#### **Related Party Transactions**

The Fund pays management and administration fees to the Manager for management and portfolio advisory services (see "Management Fees").

As at the end of the period, parties related to the Manager collectively held 1% of the Fund's units. In addition, the Pender Income Advantage Fund, a fund also managed by the Manager, held 4% of the Fund's outstanding units.

As part of the Fund's investment strategy, the Fund invests in Class O units of the Pender Corporate Bond Fund, a mutual fund also managed by the Manager. The Fund does not pay any duplicate management fees on its investment in this mutual fund.

#### **Management Fees**

The Fund pays management and administration fees calculated as a percentage of the net asset value of each respective class. The Management Expense Ratio ("MER") before applicable taxes such as GST or HST for each class does not exceed certain levels as set out in the Fund's offering documents. The fees are calculated at the close of business on each valuation day and are paid monthly. In exchange for the administration fee, the Manager pays the operating costs of the Fund.

Management fees are used by the Manager, in part, to pay sales commissions, trailer fees, marketing costs and other associated distribution costs relating to the sale of units of the Fund.

Such expenses represented approximately 18% of the management fees paid by the Fund to the Manager for the period.

The MER may vary from one class of units to another because of differences in the applicable management fees and certain fees and expenses may have been absorbed by the Manager which would otherwise be paid by the Fund.
- (c) The Manager of the Fund has agreed to absorb sufficient expenses of the Fund, as necessary, so that the annual MER before applicable taxes such as GST or HST will not exceed certain limits as outlined in the Fund's Simplified Prospectus. The amount of expenses absorbed is at the discretion of the Manager as set out in the Fund's Simplified Prospectus, and the Manager may in its sole discretion cease to absorb expenses.
- (d) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average net asset value during the period.
- (e) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the period. In general, the higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of a fund.




#### **Past Performance**




#### **Period-by-Period Returns**


